Data Protection Privacy Notice to students (and their parents/guardians)

By enrolling in and attending Bandonbridge National School, you acknowledge that your personal data (including special category personal data) shall be processed by Bandonbridge N.S.

This Privacy Notice gives you some helpful information about who we are, what personal data we collect about you, why, who we share it with and why, how long we keep it, and your rights.

1. Who we are:

We are Bandonbridge National School (also known as SN Droichead na Bandan).

We provide primary education from Junior Infants to Sixth Class.

Our school is under the patronage of the Church of Ireland Bishop of Cork, Cloyne and Ross. For further information, see our school website.

2. The information we collect about you

When you are a student with Bandonbridge N.S. we collect and use your personal data.

The personal data we collect can include information about your identity and contact details; images/photo; family details; admission/enrolment details; previous schools; academic progress; PPS number; special educational needs; nationality; language; religion; medical data; information about behaviour and attendance; information about health, safety and welfare; financial information (for payments to the school: uniforms, book rental, outings etc.) and other personal data.

Further details of the data we collect about you can be found in our Data Protection Policy.

As you are under 18 years when you enrol, we collect the name, address, contact details and other information about your parents/guardians. Your parent/guardian is consulted and asked to give consent for certain things like taking your photograph, going on school trips, access to the Internet, professional assessments, Support Teaching etc.

3. How we use your information and the legal basis

We use your personal data for purposes including:

- your application for enrolment;
- to provide you with appropriate education and support;
- to monitor your academic progress;
- to care for your health and well-being;
- to care for our staff and students;
- to process payments to the school;
- to coordinate, evaluate, fund and organise educational programmes;
- to comply with our legal obligations as an education body;
- to comply with our monitoring and reporting obligations to Government bodies, to process appeals, resolve disputes, and defend litigation etc.

4. Who we share your information with

We may share your personal data with third parties, including other Government bodies.

This includes the Department of Education and Skills, NCSE, TUSLA, An Garda Síochána, HSE, the Department of Social Protection, the Revenue Commissioners (the school has charitable status and may need your information to process donations over €250 to the school) etc.

The level of sharing and the nature of what is shared depend on various factors.

The Government bodies to which we transfer your personal data will use your personal data for their own purposes (including: to verify other information they already hold about you etc.) and they may aggregate it with other information they already hold about you and your family.

We also may share your personal data with other third parties including our insurance company and other service providers (including Aladdin: which is our current administration processor, IT providers, security providers, legal advisors etc.).

We are legally required to provide certain records relating to the progress of a student (under 18 years) in his/her education to the student's parents/guardians, including results of testing. For further information on who we share your data with, when and in what circumstances, and why, please see our Data Protection Policy available on the school website.

5. We do not transfer your personal data to a third country or international organisation.
6. We do not engage in automated decision making/profiling.
7. How long we hold your data

Some personal data is only kept for a short period (e.g. We will destroy at the end of an academic year because it is no longer needed).

Some data we retain for a longer period (e.g. retained after you leave or otherwise finish your studies with Bandonbridge N.S.

8. You have the following statutory rights that can be exercised at any time:
 - (a) Right to complain to supervisory authority.
 - (b) Right of access.
 - (c) Right to rectification.

 - (g) Right to object to automated decision making/profiling.
